## Introduction

Following the recent I-ASC Conference event in Manchester disseminating initial findings by the I-ASC team led by Professor Janice Murray, commissioners of children's health and education services across Greater Manchester have become aware of the considerable variance in the eligibility criteria for AAC across the region for those children and young adults who do not/ do not yet meet NHSE specialised AAC service eligibility criteria.

Consequently, a paper has been accepted that commits to identifying the variance in local AAC eligibility criteria beyond the remit of Specialised commissioning in order to agree standardised eligibility across Greater Manchester for local AAC provision in the future.
