



Frequently asked questions:

NHS England Specialised Commissioning Clinical Priorities Advisory Group open meeting

Twice a year, CPAG considers treatments and services that would require additional funding in order to be introduced into the NHS. Based on this prioritisation process, the Group make recommendations to NHS England about whether they should be routinely commissioned (funded) based on their relative clinical benefit and cost.

As part of a pilot for the November prioritisation process, Part I of the CPAG meeting will be open for the public to observe. In this part of the meeting, the papers and evidence for the treatments under consideration will be presented to the Group. This may include comments from stakeholder consultations and how the draft recommendations were formed. In Part II of the meeting, some of the information the Group needs to discuss is confidential and public observers will not be permitted to attend.

The open, Part I of the meeting will be held on **4th Nov at City Hall, The Queens Walk, London, SE1 2AA**. Attendees are asked to arrive at 9.30am to allow time to pass through security, register and receive a pre-briefing. **The meeting will conclude once all agenda items for Part I have been addressed, no later than 5pm**. A member of the Specialised Commissioning Communications and Engagement team will welcome the public observers as they arrive for the meeting and provide a briefing for public attendees before the meeting starts.

Who can be a public observer?

Public observers are those that can come to Part I of the CPAG meeting, but are not directly involved in the business of the meeting. Public observers might include:

- members of the public
- manufacturer representatives
- representatives from the pharmaceutical or healthcare industries
- representatives from patient, carer and voluntary sector organisations
- members of the press.

How can I register to attend the open CPAG meeting?

You can register to attend the meeting on the NHS England Specialised Commissioning website. Registration will close before the meeting takes place. A limited number of places will be available.

Please note that it may not be possible to accept late registration requests.

Once registration has closed, the NHS England Specialised Commissioning team will contact applicants via email to let them know whether they have a place at the meeting. The final agenda will be on the website at least a day before the meeting.

Can public observers take part in the meeting?

People who come to watch a committee meeting are there only as public observers. Public observers will be able to listen to the business of the meeting, except when confidential information is being discussed (see 'Will I be able to listen to all the discussions?' below for more details). However, they will not be able to participate in the Group's discussions. So they will not be permitted to ask questions during the meeting or put their own views to the members of the Group.

To help observers better understand how we make decisions, there will be a short time allocated at the end of the meeting to answer questions from the audience on the decision-making process. These questions can be submitted via the app Sli.do or via a member of the Communications and Engagement team.

What is Sli.do and what questions can I ask?

Sli.do is an app which can be used to submit questions in a user-friendly way from your phone. The app can be downloaded from your app store by searching for sli.do, or you can go to www.sli.do.com. The code for the meeting will be provided at the venue and it will be possible to post questions from the commencement of the meeting.

Attendees will be able to submit questions about the process throughout the meeting via the app and a limited time will be dedicated (approximately 10 minutes) to answering these questions at the end of the meeting. Any questions that cannot be



answered in the timeframe will be responded to via email. Please ensure you register your name on the app to allow us to check your email address via the registration form and respond to you. **Please note: we can only accept questions on the decision-making process. It will not be possible to discuss specific policies and the panel cannot accept any new information regarding any treatments under consideration.**

If I have any other questions, who should I talk to?

A member of the Specialised Commissioning Communications and Engagement team will welcome the public observers as they arrive for the meeting. They will do their best to help with practical questions about the running of the meeting and the facilities available at the venue. They will also provide a short pre-briefing for observers before the meeting begins to recap what to expect.

Please note that we cannot discuss the evidence considered, or the outcome of the meeting with public observers.

How will the CPAG meeting run?

At the start of the meeting, Sir Nick Partridge, CPAG Chair, will introduce himself. He will then move on to the business of the meeting. The following items will be discussed during the public part of the meeting:

- the agenda for the day
- the minutes of the last meeting
- whether any Group member has a conflict of interest they need to declare
- presentations on each of the treatments under consideration

Who will be at the CPAG meeting?

In addition to the Group Chair and members, members of the Specialised Commissioning team involved in running the meeting and supporting the committee will be present.

What will the Group talk about?

Following the order on the agenda, information will be heard on each of the treatments under consideration. In each case, the Group will:

- note how each proposal was developed
- consider the clinical evidence
- review the public consultation and responses received.



Will papers be available for public attendees of the meeting?

A draft agenda for the meeting will be available on the Specialised Commissioning website as soon as possible before the meeting. The final agenda will be published online at least 24 hours before the meeting.

Because other papers run to many pages and often contain confidential or copyrighted information (academic or otherwise), we are not able to provide these for public observers.

Are Patient Impact reports being used at the November 2019 meeting?

The pilot of the Patient Impact reports was due to be extended to the November prioritisation round. However, following mixed interest and feedback from patient groups on time restrictions, we have decided to pause extending the pilot for November and will revisit ahead of next May's round. This will not affect decisions at the November round and a treatment's impact on patients will be taken into account in line with the usual process through the body of reports, consultation information and data considered by the Group.

How can I keep up to date on details of where and when the CPAG meeting will be held?

In the unlikely event that the meeting time or location has to be moved due to unforeseen circumstances, we will update our website as soon as possible and contact, via email, those who have registered to attend. We advise that all attendees check the NHS England Specialised Commissioning website and their emails up to the day before the meeting to make sure they have the most up to date agenda and information about the start time and venue.

Do I need to let you know if I have registered to attend the meeting but can no longer attend?

Yes. Please inform us as soon as possible if you are unable to attend the meeting. There are a limited number of places available to observe the CPAG meeting, and by sending your apologies early, other registrants could be given the opportunity to attend.

Will I be able to listen to all the discussions?

Part I of the CPAG meeting will be open to the public. In Part II of the meeting, some of the information the Group needs to discuss is confidential and public observers will not be able to attend.

Information classed as confidential includes confidential academic or policy work. This means that public disclosure of this information could have an impact on the academic interests of a research or professional organisation, or the policy interest of the government.



Will a decision be made about any of the treatments at the public meeting?

Decisions about the treatments will need to be based on confidential information, for example, 'academic in confidence' information and will therefore take place in the closed Part II meeting. CPAG's role is advisory and final decisions are taken by the NHS England and Improvement Board.

The final decisions on which treatments will be funded as part of the twice yearly prioritisation rounds are always announced on the NHS England website. Attendees to the meeting will be kept informed on the expected date of this announcement.

How long does it take to discuss each treatment?

The length of time taken for each policy under consideration may vary depending on the type and volume of evidence under consideration. The Chair will outline the agenda for the day at the start of the meeting, and may give an indication of when certain treatments will be discussed.

It is important that all public observers arrive promptly to ensure they receive the required briefing prior to the meeting. The meeting will not be delayed for late arrivals. To keep disruptions to a minimum, late arrivals may not be allowed into the meeting until there is a suitable break.

Do I have to stay for the entire meeting?

Attendees are strongly encouraged to stay for the entirety of the meeting if possible. This is intended to encourage a global view of all the policies under consideration, not just the treatment in which they have an interest. When it is not possible for an attendee to stay for the entire meeting, they are asked to leave between agenda items to avoid disruption.

What facilities do you have to accommodate people with disabilities?

Can I quote what is said at the CPAG meeting?

We want to ensure that Group members feel able to speak freely in public meetings without concern that they may be misquoted or be quoted out of context. We therefore ask that you do not quote what is said by any person present at the CPAG meeting directly or indirectly (for example attribute the quote to an unnamed panel member or Specialised Commissioning team member) unless NHS England provides explicit approval and the relevant person has agreed to be quoted. We greatly appreciate the cooperation of observers of the meeting in this matter.



Can I report what is said at the meeting without using quotations?

Yes, external publications can publish information on what is discussed at the meeting as long as they do not attribute the text to an individual or particular group participating in the meeting (e.g. Group member or NHS England team).

Can I report what is happening at the meeting on social media?

Tweeting or live reporting from the public chamber is not permitted while the meeting is in progress.

Can I talk to members of the Group during breaks?

We ask public attendees to address any questions they have to a member of the Specialised Commissioning Engagement and Communications team. The role of Group members is to make an independent assessment of the evidence. It is therefore very important that no one tries to influence an individual Group member's view during the meeting, the breaks or outside the meeting on any topics that are under discussion by NHS England.

Interviews with external experts should be conducted away from the premises where the meeting is held. Requests for media interviews should be made through the NHS England press office. Interviews with external experts should be conducted away from the premises where the meeting is held.

Can children attend the meeting?

To keep disruptions to a minimum, children under the age of 16 are discouraged from attending the CPAG meeting but please contact us if you have any queries.

What will happen if a public observer tries to disrupt the CPAG meeting?

We expect that everyone who comes to a meeting will respect the work of the Group committee and will not cause any disruption. If a public observer causes any disruption, the individual may be asked to leave.

We may also restrict public observers who cause a disruption from attending any future meetings.
